## Academy of Continuing Legal Education Advance Registration Fee Discount Schedule for employees of small county offices.

Many continuing legal education programs offered by the Academy are of interest to attorneys and other officials employed by county governments. It has become apparent to the Academy that some counties do not have the financial resources to register their employees to attend Academy programs at the full Registration fee. The Academy has therefore adopted a Registration fee discount schedule for county offices of limited size, for Registrations received by the Academy at least ten days in advance of the program. Discounts will NOT apply to Registrations received less than ten days in advance.

This discount is intended to benefit attorneys employed by local governments in Ohio in public service. If there is a request for certification of attendance to another State, the Academy assumes that such certification is not for Ohio government public service purposes, wherefore the government-employee discount will not apply. The Academy's general rule for certification of attendance to other States is a fifty dollar surcharge for each State with which the Academy is requested to communicate, in addition to any fees charged by the State to which reporting is requested.

## Group 1: very small counties.

If your County Prosecutor or Public Defender office does not employ any attorneys full time other than the elected County Prosecutor or appointed Public Defender, you may register one attorney-employee, whether full- or part-time, for an Academy program at one-half the undiscounted price. For a two-day program with a \$490.00 full price Registration fee, your office will pay \$245.00.

For Boards of Elections which do not employ any persons year-round full-time other than the Director and Deputy Director, you may register both your Director and Deputy Director on a "buy one, get one free" basis.

For County Treasurers and other County elected officials, if your office does not employ more than two full-time year-round employees other than the elected official, you may register one employee, whether full- or part-time, at one-half the undiscounted price.

## Group 2: small counties

If your County Prosecutor or Public Defender office does not employ more than two attorneys full time other than the elected County Prosecutor or appointed Public Defender, you may register attorney-employees, whether full- or part-time, for an Academy program at 75% the undiscounted price. For a two-day program with a \$490.00 full price Registration, your office will pay \$367.50; for a one-day program with a \$215.00 full price, your office will pay \$161.25.

For Boards of Elections which do not employ more than two persons year-round full-time other than the Director and Deputy Director, you may register both your Director and Deputy Director on a "buy one, get one half price" basis.

For County Treasurers and other County elected officials, if your office does not employ more than four full-time year-round employees other than the elected official, you may register employees, whether full- or part-time, at 75% the undiscounted price.
